First: Tropical Storm Debby



SCEMD

- Landfall near Bulls Bay 8 August; three weeks of flooding in Edisto, Pee Dee, Little Pee Dee, and Waccamaw River basins.
- Rain: 22 inches in Berkeley County; 17 inches in Colleton County.
- Reported damage to more than 900 homes.
- Public agency costs and infrastructure damage projected at \$16 million+.
- Federal disaster declaration requested 16 September:
 - Individual Assistance: Charleston, Colleton, and Dorchester
 - Public Assistance for 12 counties (Bamberg, Barnwell, Berkeley, Colleton, Dillon, Dorchester, Georgetown, Hampton, Horry, Jasper, Orangeburg, and Union).
 - Public Assistance declaration approved; Individual Assistance declaration pending.

Tropical Storm Helene



SCEMD

- Peak wind speeds of 75 mph
- Rain: 21 inches in Greenville County
- Storm related deaths: 49
- Power outages: 1.3 million customers
- Road/bridge closures: 906
- Shelters
 - Peak shelters: 28
 - Peak population: 370

- Public Assistance (PA)
- Individual Assistance (IA)
- Small Business Administration (SBA) loans
- Hazard Mitigation Grant Program

Helene: at-a-glance



SCEMD

- Counties declared:
 - Individual Assistance (IA): 28
 - Public Assistance (PA): 29
- *PA estimated costs: \$292 million+
- *IA registrations: 326,500+
- *TSA: 767 households; 1,857 people
- *One shelter still open
- Debris estimate: 3 million CY



*Data changing daily



- Post-disaster housing strategy in development
 - Options to support post-disaster housing needs for displaced residents
 - By-county needs – gathering data
- State Recovery Task Force will develop Tropical Storm Helene Recovery Strategy
- Based on existing state plans, tailored for Helene

Disasters start and end locally



SCEMD

- Local response resources and capabilities are first
- State support if needed
- Federal assistance if local and state resources are overwhelmed/insufficient





- Disaster declarations unlock federal assistance when disasters exceed local and state capacity to respond and recover
- Types of Stafford Act declarations:
 - Fire Management Assistance Grant (FMAG)
 - Emergency declaration
 - Major disaster declaration

Major disaster declaration



SCEMD

Major disaster under Stafford Act:

An event that the President believes has caused damage of such severity that it is beyond the combined capabilities of state and local governments to respond

For TS Helene, FEMA-DR-4829-SC –**expedited** request submitted 9/28/2024; granted 9/29/2024

Expedited declaration



SCEMD

For rare events of unusual severity.

Allows for rapid assessment methods to determine the need for a declaration.

For Helene, submitted initial expedited request and requested counties be added as received more info.

Federal monetary assistance direct to survivors

- **Housing Assistance**
 - Financial assistance for:
 - Repair
 - Replacement
 - Max grant for FY24: \$42,500
- **Rental Assistance**

Individuals and Households Program (IHP)



SCEMD

Other Needs Assistance:

- Serious Needs Assistance (\$750)
- Displacement Assistance (two weeks' lodging)
- Funeral assistance
- Other including medical and dental, child care, and moving and storage expenses
- Clean and sanitize
- Personal property
- Transportation
- Group flood insurance policy
- Max Grant for FY24: \$42,500

Other assistance programs

- Disaster Unemployment Assistance - available
- Disaster Crisis Counseling - under consideration
- Disaster Legal Services - available
- Disaster Case Management - application being developed
- D-Supplemental Nutrition Assistance (D-SNAP) - application being developed
- Small Business Administration (SBA) low-interest loans – available
- USDA farm emergency loans

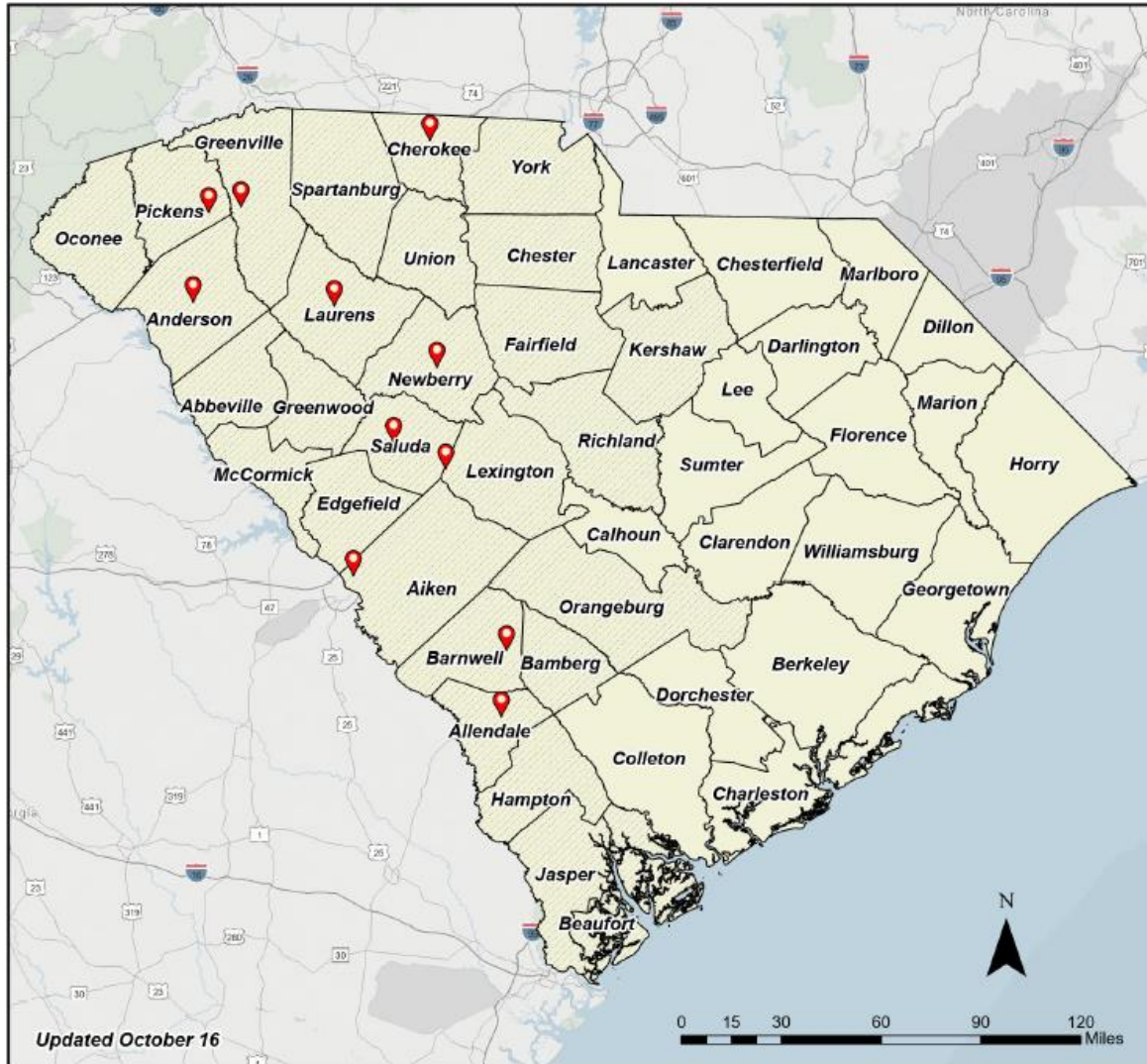

County responsibilities



SCEMD

- Publicize information about IA
- Recommend potential DRC and DLOC sites
- Coordinate timing of DRC closure
- Coordinate with DSA teams to ensure coverage of impacted areas
- Coordinate with LTRG/VOAD to facilitate meeting unmet needs
- Elevate citizen concerns about the IA process

Voluntary agencies



SCEMD

- There at the beginning - providing emergency food, shelter, clothing, and medical needs support
- There at the end - providing resources to address unmet needs
- Coordination with:
 - VOADs – Voluntary Organizations Active in Disaster
 - COADs – Community Organizations Active in Disaster
 - LTRGs – Long-Term Recovery Groups





SCEMD

Federal Public Assistance (PA)

Financial reimbursement to government entities and certain private nonprofits to address eligible uninsured losses

Public Assistance basics



SCEMD

- Federal share not less than 75%; non-federal share at most 25%
- For Hurricane Helene, 90% federal share for 90 days for debris removal and emergency protective measures

PA eligibility: applicant



SCEMD

- State government agencies
- County governments
- Municipal governments
- Federally recognized tribes
- Special purpose districts
- School districts
- Certain private non-profit organizations

Request for Public Assistance (RPA)



SCEMD

- May be submitted electronically via Grants Portal.
 - Applicants also need to register for Grants Portal, if not done so already. Please email pa@emd.sc.gov if you need assistance.
- RPAs must be submitted to FEMA within 30 days of the area being designated in the declaration.
 - **TS Helene RPA deadline is Tuesday, October 29, 2024**
- Does your organization have a UEI number?
 - A UEI # is a unique nine-digit identification number required to receive federal grants.

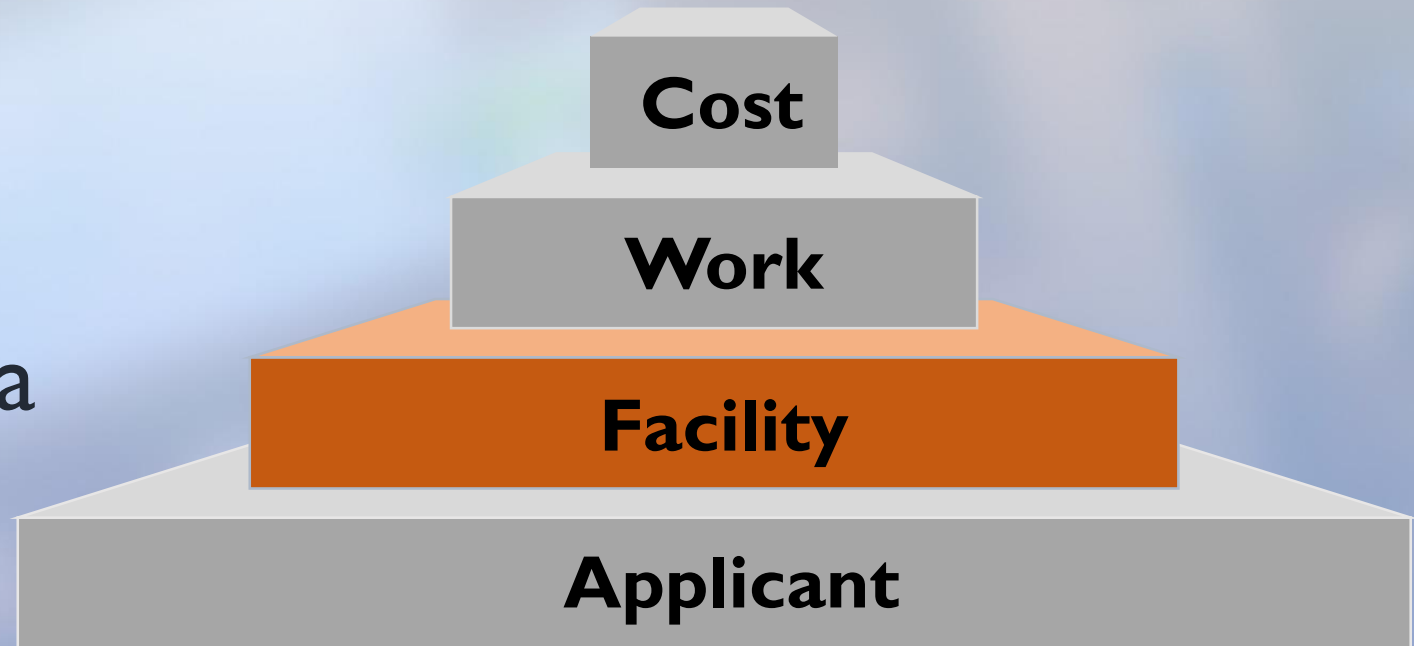
PA eligibility: facility



SCEMD

Facility:

- Damaged by declared disaster
- Located within a designated disaster area
- Legal responsibility of an eligible applicant
- Not under the specific funding authority of another federal agency



PA categories of work



SCEMD

- Emergency Work
 - A - Debris Removal
 - B - Emergency Protective Measures
- Permanent Work
 - C – Roads and Bridges
 - D – Water Control Facilities
 - E – Buildings and Equipment
 - F – Utilities
 - G – Parks, Recreation, and Other

Project development with FEMA



SCEMD

- Recovery scoping meeting
- Project formulation including scope of work and cost estimate
- FEMA review and “obligation” of project
- Conduct and complete work and maintain documentation
- Scope change and/or time extension requests through SCEMD if needed
- Quarterly reporting
- Submit requests and supporting documentation for reimbursement
- Close out
- Retain documentation for three years after closeout

Project Funding



SCEMD

Small Projects

- Greater than \$3,900, but less than \$1,037,000; projects below \$3,900 are not eligible
- Projects below \$1,037,000 may use Simplified Procedures
- Funding based on cost of work completed or initial cost estimate
- Federal cost share paid upon project approval
- Alternate or improved projects or other changes in scope require additional review by the State and/or FEMA

Large Projects

- Projects \$1,037,000 or greater
- Approved based on estimated or actual costs; paid based on documented actual costs
- Federal cost share is paid as work is completed
- Alternate or improved projects or other changes in scope require additional review by the State and/or FEMA



“Category Z” project

- Subrecipient requests Category Z project
- 5% of the project award amount for the event at the time of request
- Project will be adjusted to reflect 5%

- Proofs of Payment
- Equipment Inventories
- Procurement Policy
- Method of Procurement (advertisements, bids, quotes, etc)

Measure(s) and/or actions, usually passive, to reduce loss of life and property by lessening the impact of disasters.

Can do before disaster or after (mitigation grants or part of PA project).
