Meeting Information

The confined space course is designed to educate attendees on the safe practices and responsibilities of the entrant, entry attendant, and supervisor when working with confined spaces. Key topics include general requirements of the Occupational Safety and Health Administration standard, the employer's responsibility to individuals working in confined spaces, confined space recognition, requirements for entry, atmospheric hazards, physical hazards, personal protective equipment and regulatory requirements.

Upon completion of this course, attendees will be able to

- identify criteria for confined spaces and permit-required confined spaces;
- list four main hazards that may exist in permit-required confined spaces;
- describe at least one hazard control method for each of four main confined space hazards;
- discuss your duties as a member of the confined space entry team (supervisor, attendant, entrant); and
- apply OSHA training requirements to site specific conditions.

The SC Municipal Insurance Trust and SC Municipal Insurance and Risk Financing Fund strongly encourage public works and utilities staff, safety coordinators and risk managers to attend. Attendance at this session counts toward risk self-assessment compliance and as a core course for participants in the Risk Management Institute.
